In 2016, to address the local affordable housing crisis, Da Dagghay Development Corporation (DDDC) partnered with Ta'an Kwäch'an Council, Yukon Government, and Canada Mortgage and Housing Corporation on a 42 unit build in Whistle Bend. The Partnership provided affordable rental solutions to TKC Citizens and Yukoners alike. With the successful partnerships created in Phase I, DDDC started construction of 2 additional buildings (28 more units) in 2019 and which will increase the total number of units to 70 by the end of 2020.

Our goal at DDDC Property Management is to provide access to housing for TKC families entering the rental market and wanting to transition into future home ownership. DDDC Property Management would like to welcome you to join our housing community.
